- 5. Participants are strictly not permitted to use mobile phones during session time.
- 6. - 10. If for reasons unforeseen a batch does not commence on the nominated/declared date, or the coaching completion of a particular Program session /course is not over as scheduled then a suitable alternate date or extension of the Program duration shall be allowed.
